Performers may request a specific performance time, but time slots will be filled on first come first serve basis and may be adjusted by the organizers if necessary to accommodate as many performers as possible. You will be notified of your final time slot by the beginning of May.

If performers are doing a theater production or literary performance that is not their own original work, the performer is responsible for first obtaining a performance license/permission from the creator of that work. Musical performance licenses will be covered by an ASCAP license associated with the event as long as that piece is listed in the ASCAP online catalogue <https://www.ascap.com/ace>.
